



▲ Manager's Comment

In November, the market saw a noticeable improvement in sentiment as expectations of interest rate cuts rebounded. Several economic data points in the United States fell below expectations, leading to a decline in US bond yields across the board. The 10-year US Treasury bond yield decreased by 60 basis points throughout the month, and the market is pricing in a rate cut of over 100 basis points for next year. In the credit bond market, global credit spreads further narrowed, with most sectors reaching new lows for the year. Chinese property bonds also experienced some rebound stimulated by policy measures. It is advisable to appropriately lengthen the overall portfolio's duration and adopt a barbell strategy for credit and maturity, maintaining a relatively cautious approach towards high-yield sectors and Chinese property sectors, with a focus on short-term trading.
