

#### ▲ Manager's Comment

In January 2024, the market and the Federal Reserve made some adjustments to the expectations of an early interest rate cut, but overall risk sentiment remained optimistic. Against the backdrop of strong US economic data, US bond yields rose in the first half of the month. The central bank aimed to control market expectations, while the upward momentum of US bonds was somewhat restrained due to expectations of improved supply-demand dynamics. The yield curve steepened as a whole. Supported by fundamental, sentiment, and technical factors, credit spreads further compressed, with some sectors approaching or even breaking the lows of 2021. During market rebounds, it is advisable to reduce real estate positions further and increase allocations to quasi-sovereign bonds of countries with good growth potential in the Asian region.
