

### Manager's Comment

In May, the market remained volatile under the influence of shifting U.S. trade policies. Early in the month, news of a tariff suspension boosted market sentiment, leading to a notable rebound in major risk assets. However, concerns over U.S. Treasury supply and the fiscal deficit drove Treasury yields significantly higher. Despite this, the positive impact of narrowing credit spreads in Asian USD bonds outweighed the negative effect of rising U.S. Treasury yields on bond prices. Against this backdrop, the JACI Core Index recorded a positive return of 0.64% in May.

Looking ahead, market attention remains focused on the ultimate direction of U.S. trade policy, the resilience of growth in major global economies, and inflation data. We will closely monitor how these factors influence U.S. Treasury yields and credit spreads. The fund will continue to strictly control risk while prudently assessing the economic fundamentals and policy orientations of Asian countries. It will dynamically adjust portfolio duration and sector allocation in an effort to uncover high-quality bonds with relative value in a volatile market environment.




