

### ▲ Manager's Comment

In January, U.S. Treasury yields generally moved higher, with increases of approximately 3–7 basis points across different maturities, indicating that the rate environment continues to exert some valuation pressure on duration-sensitive assets.

On the policy front, the Federal Reserve kept the target range for the policy rate unchanged at 3.50%–3.75% at the January FOMC meeting, reflecting a continued “data-dependent” approach to the future policy path. Asian credit markets overall remained resilient, with returns mainly driven by coupon income and relatively stable credit spreads. The JACI Core Index recorded a total return of +0.32% in January.

Under the base-case scenario in which the long end of the yield curve is affected by term premium, supply dynamics, and policy uncertainty, and interest-rate shocks may recur, portfolio strategy prioritizes controlling interest-rate risk through structural positioning. This aims to reduce sensitivity to directional rate movements, while emphasizing certainty and credit quality in credit allocation. Positioning will remain focused on high-quality issuers with strong credit fundamentals and greater financing resilience, while also favoring issuers with higher cash-flow visibility and more robust balance sheets. The objective is to achieve more stable coupon-type returns in an environment of rate volatility, while maintaining a cautious stance toward segments with stronger event-driven characteristics and higher volatility.




