



▲ Manager's Comment

In July, various economic indicators in the United States performed strongly, driving further increases in US Treasury yields. Although the cooling of inflation data to some extent curbed the upward momentum of interest rates, long-term yields continued to rise. As expected, the Federal Reserve raised interest rates by 25 basis points and stated that future rate policies would still be data-dependent. The Chinese investment-grade USD bond market remained stable, while the high-yield sector experienced significant volatility due to multiple credit risk events in the real estate sector. In the current market environment, our portfolio management strategy still prioritizes risk management, maintaining a relatively short duration to fend against the upside risk of interest rates, and rigorously monitoring the credit quality of the portfolio.
