- ChinaAMC Select Fixed Income Allocation Fund (the "Fund") seeks to achieve capital appreciation by investing not less than 70% of the NAV in fixed income and debt instruments in markets worldwide.

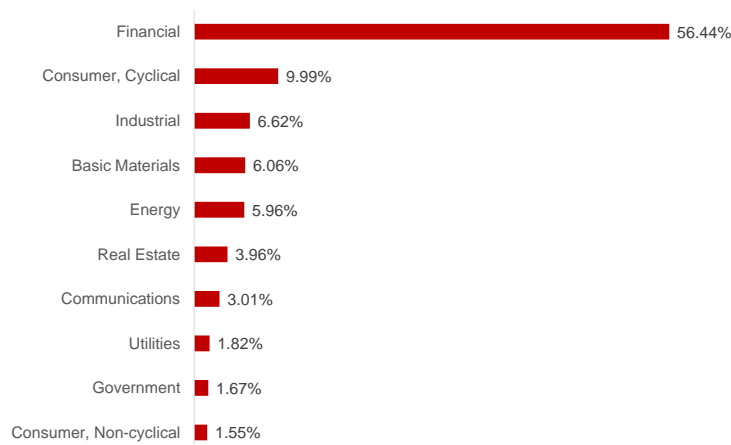

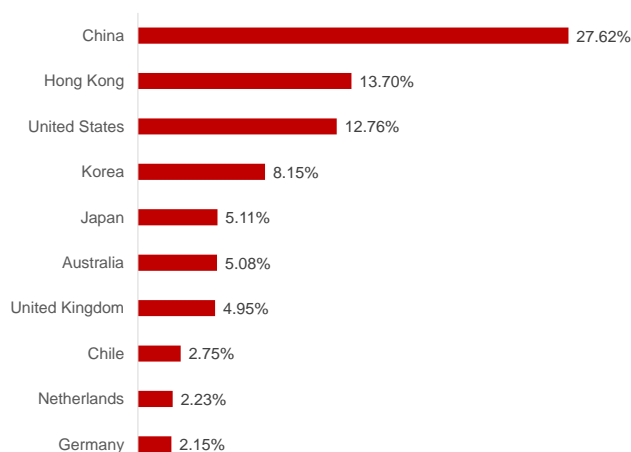


▲ Portfolio Allocation

▲ Manager's Comment

In March, global markets experienced volatility as the Federal Reserve's FOMC meeting maintained its projection of three interest rate cuts for the year. The rise in energy and commodity prices led to another surpassing of expectations in US CPI data, while the US economy continued to display resilience. The market's expectations for the timing of the first interest rate cut by the Federal Reserve were pushed back, resulting in a 0.14% increase in the global short-duration bond index for the month.

Given the current backdrop of inflation and the US economy, there remains some uncertainty regarding the timing of the initial interest rate cut. In a high-interest environment, a combination of medium and short-duration bond portfolios can still provide relatively stable and attractive returns.
