

▲ Manager's Comment

In August, market attention was focused on the Federal Reserve's policy shift. Fed Chair Jerome Powell's dovish remarks, along with downward revisions to employment data that raised market concerns, sharply heightened expectations for a rate cut in September. This drove a notable steepening of the U.S. Treasury yield curve, with short-term rates falling significantly. Although credit spreads followed a V-shaped trajectory during the month, short- to medium-duration bonds performed steadily under the influence of falling interest rates. The Bloomberg 1-3 Year Bond Index posted a total return of 0.88% in August.

Currently, the market has largely priced in the Fed's rate-cut path, while asset valuations remain generally elevated, making short-term correction risks hard to ignore. In this environment, short- to medium-duration bonds continue to offer strong defensive value. The portfolio will maintain its core strategy of focusing on short- to medium-duration holdings to secure relatively stable coupon income and manage volatility. We will strictly control credit risk and remain alert to potential shifts in market sentiment triggered by fluctuations in U.S. economic data or concerns over the Fed's independence.




