

## ▲ Manager's Comment

The main theme of the September market began with weak U.S. non-farm payroll data at the start of the month, which reinforced market expectations that the Federal Reserve would begin cutting interest rates. In mid-September, the Fed officially announced a 25 basis point rate cut and hinted that labor market weakness could prompt further action. This move anchored expectations for shortterm interest rate declines, with the yield on 2-year U.S. Treasury bonds slightly retreating during the month. Although long-term rates experienced increased volatility, the overall environment remained stable for the short-term bond market, which is less sensitive to duration. Under this interest rate environment, short- to medium-duration bonds performed steadily, with the Bloomberg 1-3 Year Bond Index recording a total return of 0.33% in September.

The market has now fully priced in the path of future rate cuts, and further easing may depend on whether economic data deteriorates beyond expectations. Against the backdrop of generally tight credit spreads, the defensive characteristics and certainty of coupon income from short- to mediumduration investment-grade bonds have become increasingly prominent. The portfolio will continue to adhere to its core strategy of short- to medium-duration positioning, using high-quality investmentgrade credit bonds as its allocation cornerstone, strictly controlling credit risk, and aiming to provide investors with a "safe haven" for stable value growth in an uncertain market.




