

### ▲ Manager's Comment

The October market focused on the Federal Reserve's policy deliberations. While the Fed's 25-basispoint rate cut aligned with expectations, its hawkish rhetoric prompted markets to reprice expectations for further December cuts, causing interest rates to initially decline before rebounding. For the shortterm bond market with lower duration sensitivity, the overall environment remained stable, with the 2year Treasury yield edging down slightly during the month. In this interest rate environment, mediumto-short duration bonds performed steadily, with the Bloomberg 1-3 Year Bond Index recording a total return of 0.345% in October.

Currently, while risk appetite has shown signs of recovery, underlying liquidity and credit risks are gradually surfacing. This further highlights the defensive attributes and certain coupon value of medium-to-short duration investment-grade bonds. The portfolio will continue to strictly adhere to its core strategy of medium-to-short duration, using high-quality investment-grade corporate bonds as the cornerstone of its allocation. It will rigorously control credit risk exposure, striving to deliver stable returns for investors in volatile markets.




