## ▲ Manager's Comment

The market narrative in November shifted back to pricing in weak economic fundamentals. With the end of the U.S. government shutdown and the University of Michigan Consumer Sentiment Index falling to a multi-year low in November, market expectations for further Fed rate cuts in December and next year intensified. This momentum drove a significant decline in short-end rates, with the 2year Treasury yield falling 8 basis points over the month to 3.49%. Driven by both falling yields and accumulating coupon income, medium-to-short duration bonds delivered standout performance, with the Bloomberg 1-3 Year Bond Index posting a total return of +0.4647% in November

Current macroeconomic data indicates signs of a slowing U.S. economy, further highlighting the allocation value of medium-to-short duration bonds during this rate-cutting cycle. Although risk appetite has somewhat recovered, considering potential year-end liquidity tightening and recession trade risks, the low-volatility characteristics of medium-to-short duration bonds appear increasingly valuable. The portfolio will continue to adhere to its medium-to-short duration strategy, leveraging opportunities arising from the current yield curve inversion to capture yields from high-quality credit bonds, delivering returns that balance liquidity and security for investors




