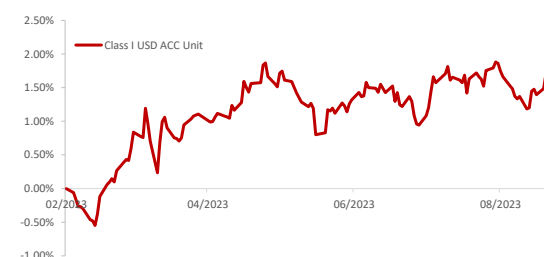

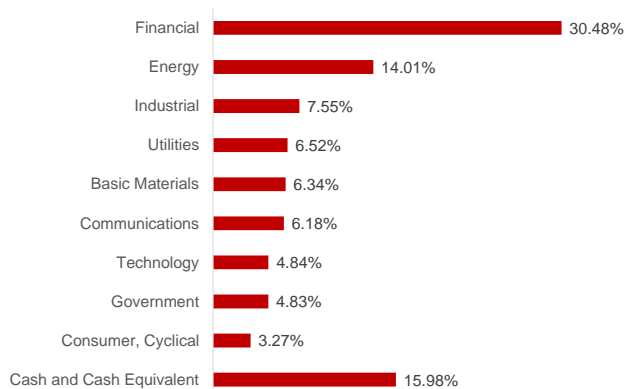

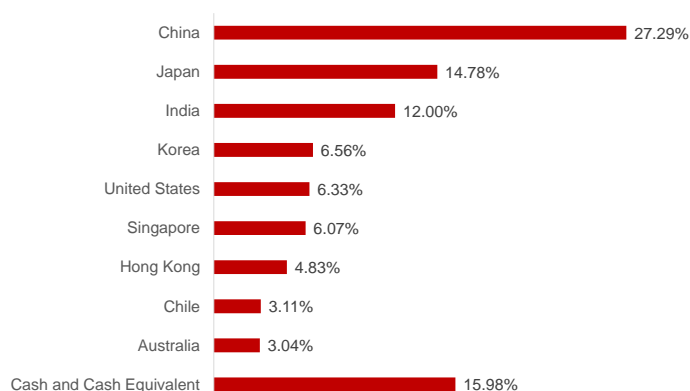

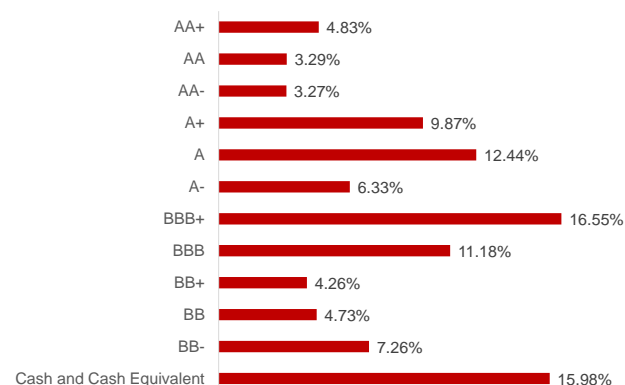
#### Sector Exposure (%)



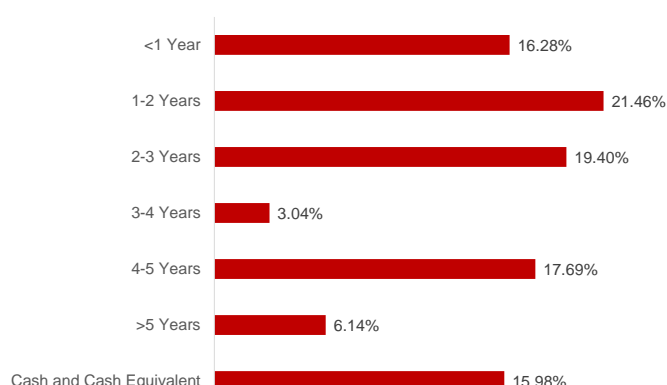
#### Geographical Exposure (%)
