

▲ Manager's Comment

In October, the market still maintained high volatility in the face of many uncertainties, and different markets showed great differentiation. In the first half of the month, U.S. employment and inflation data continued to exceed market expectations, and the interest rate and duration of interest rate hikes continued to rise to 4.34%. In the second half of the month, the market made some corrections to the early overreaction, and developed markets rebounded to a certain extent, while the outflow of foreign capital from China continued to put pressure on Chinese assets. In terms of credit bonds, developed markets outperformed emerging markets, while Chinese capital significantly lags behind. LGFV and non-bank financial sectors weaken. After the 20th National Congress of the Communist Party of China, the sentiment in the real estate sector continued to be sluggish and prices continued to drop significantly. The portfolio is dominated by high-grade bonds, maintaining a highly diversified allocation of industries and countries and maintaining a high interest rate hedging ratio.
