

### **▲ Manager's Comment**

After the market opened in 2023, overall market sentiment improved significantly as China's economy recovered, U.S. interest rate hikes peaked and recessionary pressures in Europe eased. U.S. CPI and GDP were both better than expected, and U.S. bond yields fell across the board, but remained deeply inverted. In credit bonds, long duration outperformed short duration and high beta outperformed low beta. Investment grade credit spreads of Chinese USD bonds returned to the low level in the past year and high yield continued to rebound. We should allocate more long duration high quality bonds and use futures to hedge against interest rate fluctuations to enhance returns.
