

### ▲ Investment Objective

The Fund seeks to achieve capital appreciation and income generation by investing primarily in onshore RMB denominated equity securities issued by issuers based in, or having a significant exposure to, Mainland China and Hong Kong, as further described below. The Investment Manager contemplates investing directly into China A-Shares using its QFI status and the Stock Connect. As at the date of the Fund's prospectus, the Investment Manager, when using Stock Connect, will be limited to investments in China A-Shares listed on the SSE and the SZSE.





## ▲ Manager's Comment

In May 2023, the Wind All Share Index fell by 3.31%, and the ChiNext Index fell by 5.65%. Meanwhile, the Hang Seng Index fell by 8.35%, while the US Dow Jones, S&P 500, and Nasdaq indexes performed at -3.49%, +0.25%, and +5.80%, respectively. The US market outperformed A-shares and Hong Kong stocks. From the perspective of industry sectors, power and utilities, electronics, computer, and communication sectors saw positive returns, while consumer services, agriculture, construction, non-ferrous metals, and food and beverage sectors lagged behind the market.

Both A-shares and Hong Kong stock markets showed new declines in May, with the Hong Kong market experiencing a larger decline, as in April. We believe the main reason is the weak economic recovery in China, especially the significant decline in economic data in April, which indicates a lack of confidence among economic participants. The lower-than-expected economic data has led some investors to expect the Chinese government to launch more significant stimulus measures, including in the real estate industry. However, the government did not introduce any stimulus measures in May, which further increased investors' concerns about the economy. At the same time, the Japanese government's inclusion of cash semiconductor manufacturing equipment and 23 other items in the list of objects subject to export controls has also increased investors' concerns about China's external geopolitical environment. Defensive and thematic industries outperformed the market, while growth-oriented industries such as consumer services lagged behind.

Looking ahead, the core contradiction of this round of Chinese stock market adjustment is the development prospects of China's economy itself and whether China's external political environment can improve. We need to observe whether the Chinese government will introduce more extensive economic stabilization measures in June and July, and whether China-US relations can improve in stages following several rounds of official talks in May. We maintain our judgment that the Chinese stock market will continue to fluctuate upward. We will focus more on long-term policy-encouraged industries such as autonomous and controllable, advanced manufacturing, and information technology, as well as short-term investment opportunities related to the reopening of the economy, such as consumption and healthcare.
