- ChinaAMC Select China Leap Equity Fund (the "Fund") invests primarily in equity securities of China-related companies with registered offices located in the People's Republic of China ("PRC") and/or Hong Kong, and/or China-related companies that do not have their registered offices in the PRC or Hong Kong which in the opinion of the Manager, have strong prospects for leap growth or will benefit from leap growth of China, by accessing whether the company's business revenue is driven by Chinese consumption increase, technology progress or demographic trend, or whether the company is covered by the development plans of the Chinese government, including but not limited to the "14th Five-Year Plan of China", the "Made in China 2025 Plan", the "Carbon Neutrality Strategy of China".

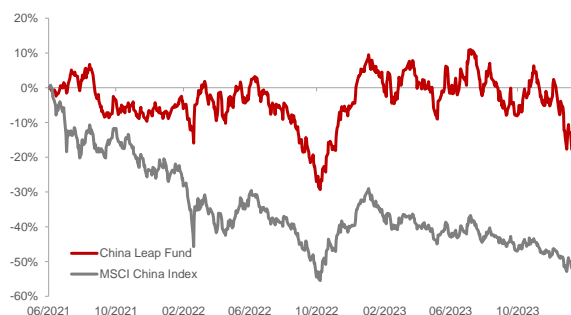
### ▲ Investment Objective

The Fund seeks to maximize capital growth by investing primarily (i.e. at least 70% of its net assets) in equity securities (such as but not limited to listed shares, depositary receipts, and exchange traded funds) of China-related companies with registered offices located in the People's Republic of China ("PRC") and/or Hong Kong, and/or China-related companies that do not have their registered offices in the PRC or Hong Kong but either (a) carry out a predominant proportion of their business activities in the PRC or Hong Kong, or (b) are holding companies which predominantly own companies with registered offices in the PRC or Hong Kong, which, in the opinion of the Manager, have strong prospects for leap growth or will benefit from leap growth of China ("China Leap Equity Securities").

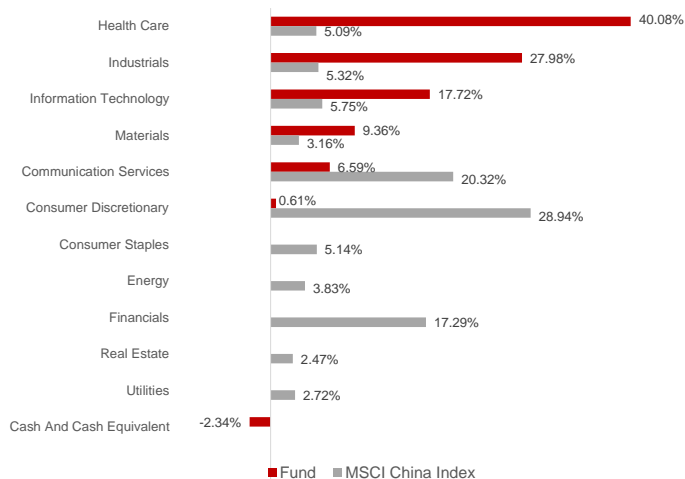

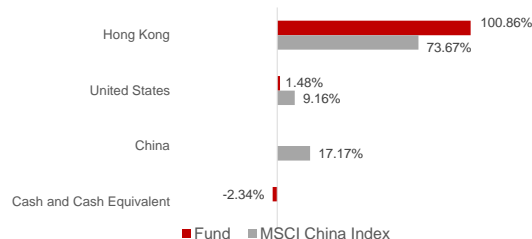


### ▲ Portfolio Allocation

### ▲ Manager's Comment

MSCI China index dropped by 10.51% in January, led by lack of necessary policy responses to boost business and consumer confidence, concerns about US-China relations, early worries about Hong Kong's fiscal conditions, and the unwinding of onshore structural products. Despite the challenges, there have been positive developments. On Jan 2, the PBoC announced the reintroduction of PSL after a hiatus of more than 10 months. On Jan 24, the Governor of the PBoC, Pan Gongsheng, unexpectedly announced a 0.5ppt RRR cut. Additionally, the SASAC stated their comprehensive promotion of market value management inclusion in the performance appraisal system for executives at listed SOEs, benefiting investors and facilitating high-quality development through improved competitiveness.

The fund underperformed the benchmark in January. The underperformance of the fund in January can be attributed primarily to its sector allocation in healthcare, financials, information technology, and energy, as well as the stock selection within industrials, consumer discretionary, healthcare, and communication services, while its sector allocation in consumer discretionary, consumer staples and industrials resulted in some positive relative returns.

Looking forward, we maintain our long-term positive view on China equity market. Apart from the measured and recurrent purchases of leading indices by the national team, policy actions are focused on rebalancing the equity market's microstructure and enhancing returns to shareholders, aiming for more consistent outcomes. The ban on new lending of restricted shares is a positive development, and the existing stock loan book will gradually expire, alleviating selling pressure. For SOEs, the introduction of new KPIs such as ROE and operating cash flow, implemented last year, is likely to expand to incorporate market value management, while cash dividends and share buybacks are encouraged. Furthermore, we anticipate that feedback from the current market conditions and sentiment will drive the introduction of more favorable policies. In terms of portfolio positioning, we will continue to seek a balance between value and growth.
