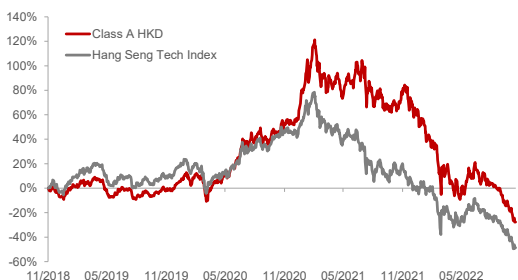

- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

### ▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

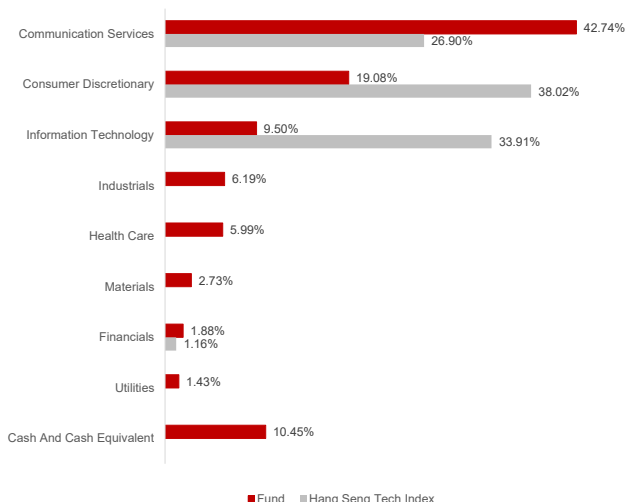

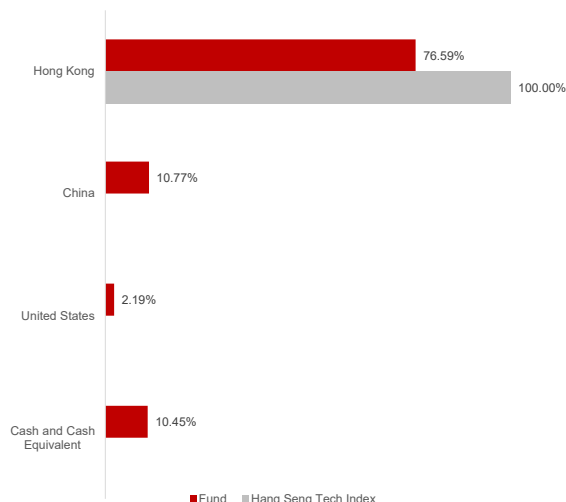


### ▲ Portfolio Allocation

### ▲ Manager's Comment

The Hang Seng Technology Index continued its decline in October, closing down 17.32% for the month. Under the repeated epidemic situation in the mainland, many leading Internet companies revised down their short-term profit forecasts. With the addition of interest rate hikes in overseas developed economies and the continuation of geopolitical risks, some overseas funds have flowed out of the Hong Kong stock market, and the main constituent stocks of the Hang Seng Technology Index, as the core positions of foreign institutions, are facing greater selling pressure. The United States released more restrictions on China's semiconductor-related exports and announced new restrictions on China's supercomputing development. Semiconductor-related stocks fell sharply after the information was released, followed by sentiment recovery and domestic substitution in the A-share market/self-controllable sectors. The stock price has been repaired obviously, and some software stocks have followed the strength of the A-share sector to become one of the few bright spots in the market crash.

The fund performed slightly better than the Hang Seng Technology Index in October. The excess returns were mainly contributed by position management and individual stock selection, while the performance of the industry allocation was slightly worse than the index. The fund's selection of individual stocks in all industries has achieved excess positive returns, and the selection of individual stocks in the communication service industry has achieved significantly positive excess returns. In terms of industry allocation, investment managers underestimated the magnitude and strength of the domestic substitution/self-controllable market represented by domestic software and semiconductors after the United States introduced semiconductor-related export restrictions, and the low allocation in the information technology industry produced a certain excess negative income.

Looking forward to the market outlook, considering that there are still many internal and external uncertainties, the short-term market is expected to continue to show a wide-ranging trend of high volatility. The fund will continue to maintain a balanced allocation under the premise of controlling overall risks, and respond to the highly volatile market environment by flexibly adjusting positions and selecting individual stocks. The audit supervision of Chinese concept stocks, the development of the new crown epidemic in mainland China and its prevention and control measures, the geopolitical risks represented by China, the United States, Russia and Ukraine, and the progress of interest rate hikes in overseas developed economies will be the main factors affecting the market trend.
