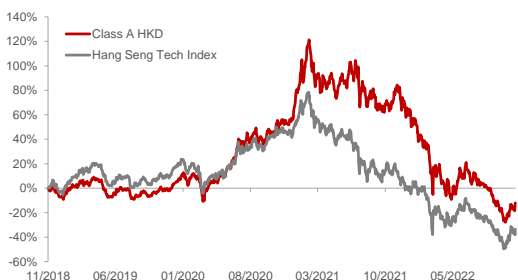

- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

### ▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

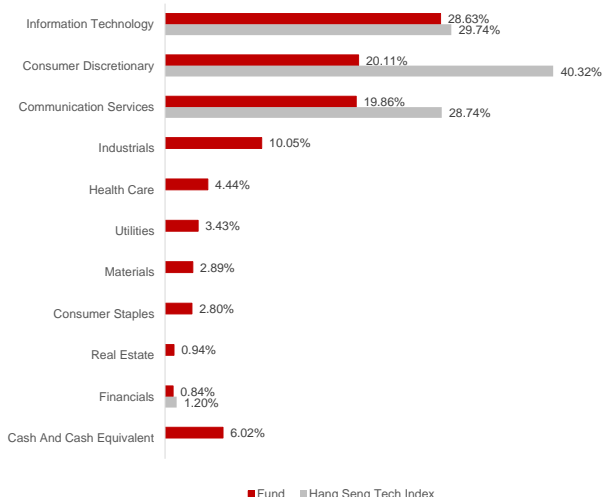

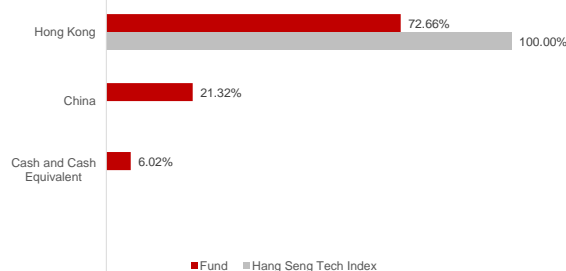


### ▲ Portfolio Allocation

### ▲ Manager's Comment

The Hang Seng Technology Index rebounded sharply in November, closing up 33.15% for the month. The process of reopening economy in Mainland China has officially begun, and the "20 measures" epidemic prevention and optimization measures will help reduce the impact on economic activities. Although the number of new cases remains high, given that the pathogenicity of the new coronavirus has been greatly weakened, the optimization of epidemic prevention and control measures in the mainland of China will continue with a high probability. U.S. auditors have completed the first round of on-site inspections of the audit papers of Chinese firms ahead of schedule, and are expected to submit a preliminary report in the next few weeks. Investors' concerns about the delisting risks of Chinese concept stocks have significantly weakened. In terms of Internet industry regulatory policies, the Chinese government has recently repeatedly expressed its support for the healthy development of the platform economy and digital economy. Positive progress has been made in Internet financial rectification and game version number issuance. In addition, with the introduction of intensive support policies for the real estate industry, the credit risk of China's real estate industry has dropped significantly, and the market's expectations for China's economic growth have increased significantly, which will also help the performance of stocks in the Greater China technology sector.

The performance of the fund lagged behind the Hang Seng Technology Index in November, mainly because there were still many internal and external uncertainties in the early stage of the rebound. The fund as a whole continued its previous stable investment strategy. The fund continued to perform well in stock selection in major industries, but the cash position, A-share position and some defensive stock positions dragged down the performance of the fund's net value in the case of a sharp rise in the Hong Kong stock market. Looking ahead, the reopening of China's economy and the introduction of more vigorous measures to stabilize growth will help accelerate the pace of China's economic recovery and support the performance of the medium and long-term market. In the short term, after the market rebounded in November, the valuations of most stocks have been significantly restored. We will adopt stricter standards for the selection of individual stocks in investment, and strive to achieve steady growth in the net value of funds in the medium and long term. The development of the epidemic situation in mainland China, the adjustment of follow-up epidemic prevention policies, the Central Economic Work Conference in December, and whether the risk of delisting Chinese concept stocks before the end of the year will be an important factor affecting the short-term market trend.
