- ChinaAMC Select Greater China Technology Fund (the "Fund") will invest primarily in China-Related Technology Companies and in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies"). The Fund may invest a small portion of its assets in fixed income securities, equities listed on stock exchanges around the world other than the Greater China, other collective investment schemes and invest directly in Mainland China securities.
- The Fund will invest in equity securities and is subject to general market risk and the prices of such securities may be volatile.
- The Fund may also invest in companies of any market capitalization including but not limited to companies with small or medium market capitalization. The stocks of companies with small or medium market capitalization may have lower liquidity and their prices are more volatile to adverse economic developments than those of larger market capitalization companies in general.
- The Fund will focus its investments on China-Related Companies and such investments will increase the Sub-Fund's vulnerability to the economic, political or regulatory or tax developments of a single country such as China. Also, the Fund is likely to be more volatile than a fund having a more diverse portfolio of investments.
- The Fund may invest in the PRC markets, which involve certain risks and special considerations not typically associated with investment in more developed economies or markets, such as greater political, tax, economic, foreign exchange, liquidity, legal and regulatory risk.

▲ Investment Objective

The Fund seeks to achieve long term capital growth by primarily (i.e. not less than 70% of its Net Asset Value) investing in China-Related Technology Companies (as defined below). To achieve the investment objective, not less than 70% of the Fund's Net Asset Value will be invested in equities of technology companies which, in the opinion of the Manager, will likely benefit from innovations, use of new technologies or offering products and services that meet the demands of the new and evolving China economy ("China-Related Technology Companies") with registered offices located in the Greater China area (including Mainland China, Hong Kong, Macau and Taiwan), and/or China Related Technology Companies that do not have their registered offices in the Greater China area but either (a) carry out a predominant proportion of their business activities in Greater China or (b) are holding companies which predominantly own companies with registered offices in Greater China.

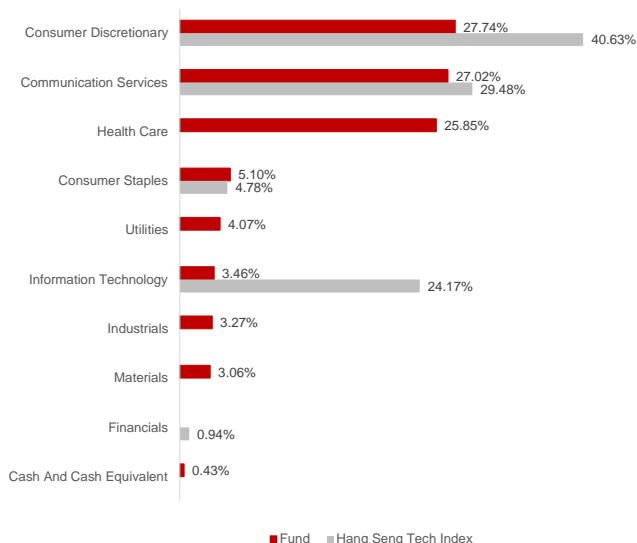

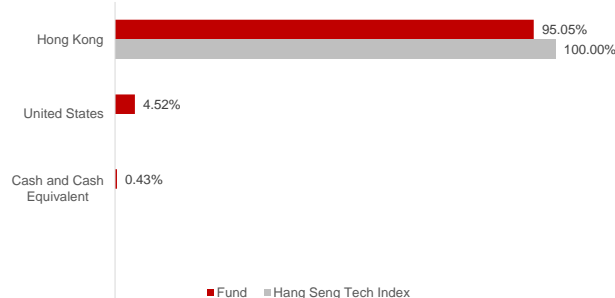


▲ Portfolio Allocation

▲ Manager's Comment

The Hang Seng Tech Index rose 7.85% in June. Weak economic data enhanced expectations for stimulus policies, and coupled with the easing of US-China relations, the market temporarily departed from the downward trend in May during the first half of June. However, starting in mid-June, investor optimism receded again due to the actual implementation of stimulus policies falling below expectations, the resurgence of restrictions in the technology sector, hawkish stances by global central banks, and a weakening Chinese yuan. On June 13th, the People's Bank of China lowered the 7-day reverse repo rate by 10 basis points, exceeding market expectations and pushing up expectations for more easing measures. On June 16th, Premier Li Qiang presided over an Executive Meeting of the State Council and announced that a series of policies to stabilize economic growth would soon be implemented. On June 28th, the People's Bank of China held a monetary policy meeting for the second quarter, announcing that it would increase countercyclical adjustments, support the expansion of domestic demand, improve the consumption environment, promote a virtuous cycle of the economy, and provide stronger support for the real economy.

The fund's performance in June was slightly weaker than that of the Hang Seng Tech Index. The fund achieved positive excess returns in stock selection in the information technology industry and in industry allocation in communication services, information technology, and raw materials. However, the fund recorded negative excess returns in stock selection in discretionary consumer goods, communication services, and industry allocation in discretionary consumer goods. The fund will continue to adhere to a stable and sustainable investment philosophy, and strive to achieve better performance in the medium to long term through reasonable industry allocation and bottom-up stock selection.

Looking ahead, against the backdrop of a significant slowdown in export growth and weak domestic demand, policy makers have turned to a more proactive policy stance to stabilize economic growth, including implementing moderate interest rate cuts, announcing tax cuts/fee deferrals for the corporate sector, targeted stimulus measures for specific products (new energy vehicles, home appliances, and furniture), and accelerating the issuance of local government special bonds. In addition, China and the US are resuming dialogue on a broader basis, and Janet Yellen's visit to China following Blinken's visit suggests that US-China relations are showing a clear easing trend in the medium term. We will observe whether more stable growth measures will be introduced at the State Council meeting in mid-July and the Political Bureau meeting in late July.
