The Renminbi Equity Trading Support Facility (the “TSF”) was launched on 24 October 2011 by the Hong Kong Exchanges and Clearing Limited to provide a facility to enable investors who wish to buy RMB-traded shares (RMB shares) in the secondary market with Hong Kong dollars if they do not have sufficient RMB or have difficulty in obtaining RMB from other channels. With effect from 6 August 2012, the coverage of TSF has been extended and ChinaAMC CSI 300 Index ETF (Stock Code: 83188) is eligible for the TSF. Investors should consult their financial advisers if they have any questions concerning the TSF.
